The club's activities are designed to meet the needs of all its members, regardless of ability, and stresses sportsmanship, discipline, friendship, goodwill and cooperation within its membership.

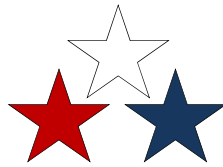

- In the event of ineligibility or temporary suspension/loss of USFS membership, a \$100 reinstatement fee will be assessed

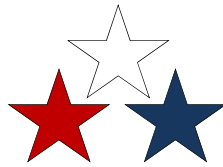

## **NORTHERN BLADES NSC FIGURE SKATING CLUB**

### **2020-21 CODE OF CONDUCT**

---

Northern Blades National Sports Center Figure Skating Club ("NBNSCFSC") supports a zero tolerance policy for unsportsmanlike behavior. Its members, whether athletes, professionals, parents or supporters should continually raise the standard of behavior to create a comprehensive skating experience, where hopes and dreams are realized, through a supportive and inspiring network of people and experiences.

#### **RULES OF ENGAGEMENT**

1. Always assume good intentions.
2. Treat others as you would want to be treated.
3. Always come from a perspective of understanding vs. blaming or criticizing.
4. Be solution minded! Always search for solutions rather than blaming.
5. Opinions are always welcomed, but, once a decision has been made, stand behind the decision for the forward progress of the program/Club.
6. Everyone should bring their "best" self and attitude to skating each day.
7. If a problem or issue should arise, raise it with those individuals that can most effectively and efficiently deal with the issue or problem. Gossip, rumors and negative PR will not be tolerated.
8. It is ok to say "I'm sorry". Everyone makes mistakes. This is how we learn and grow. Maintaining relationships is more important than being right or getting in the last word.
9. Remember we are all here for the betterment of the *overall* skating program and experience! We can accomplish more together, than separately. If we all work together; Skater, Coach, Parent, Board Member, Volunteer, NSC Staff, etc. then we will produce a greater experience for all!

#### **PROFESSIONAL MEMBERS RESPONSIBILITIES**

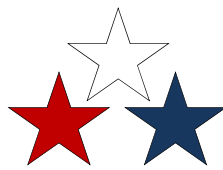

I will support and respect the NBNSCFSC by encouraging membership, good sportsmanship behavior and by showing positive support for all members, coaches, board members, judges, officials and rink management both on and off the ice and will encourage the same from my child. I will support the expectations of skaters and follow the expectations of parents as outlined on the following page.

#### **SKATER RESPONSIBILITIES**

I will support and respect the NBNSCFSC by encouraging membership, good sportsmanship behavior and by showing positive support and respect for all members, coaches, board members, judges, officials and rink management both on and off the ice. I will follow the rules of skater etiquette as published by the National Sports Center and NBNSCFSC. I will support and follow the expectations of skaters as outlined on the following page.



### COURSE OF ACTION

Should a parent, member or professional not adhere to the above Code of Conduct, NBNSCFSC Board of Directors will hold the member, parent or coach accountable and will take necessary action that may be as simple as a verbal warning up to disciplinary hearings before the Board of Directors. At such time the Board of Directors will decide if suspension or expulsion from NBNSCFSC is in order.

### ACKNOWLEDGEMENT

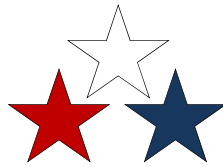
I will read and understand the terms and conditions set forth in this document and the expectations outlined below and on the following page(s) and agree to adhere to them.

### EXPECTATION OF SKATERS

1. I will work toward and support:
  - a. Individual growth and excellence in figure skating.
  - b. Positive and constructive behavior with all of my fellow skaters, other parents and professional staff in the Club.
  - c. Respect and appreciation for the individual and different personalities and skills of all skaters and Pros.
  - d. Feeling of "belonging" to the Club, Club unity and working together to accomplish Club goals.
  - e. Support and respect for all skaters participating in competitive events.
2. I will be respectful of all skaters, Pros and others at the ice arena by exhibiting appropriate behavior at all times.
3. I will abide by the disciplinary procedures as outlined in the Expectations of Professional Staff and restated below:
  - a. All Pros are responsible to be observant for inappropriate skating etiquette.
  - b. If inappropriate skating etiquette is observed, the Pro of the skater involved and the Pro who observed the behavior will meet off the ice and all parties will address and resolve the problem. This will take place at the time of the incident. If the skater's Pro is not present, the issue will be discussed with the skater, and the skater's Pro will be notified as soon as possible.
  - c. If I disagree with how I was treated, I will follow the grievance procedure, as outlined by the Board.
4. I will conduct myself chemically free (alcohol, illicit drugs) whenever participating in a Club skating session, exhibition or skating competition.

### EXPECTATION OF PARENTS

1. I will review and explain the Expectations of Skaters with my skater(s). I will support and respect these Expectations.
2. I will review and explain the Expectations of Professional Staff with my skater(s). I will support and respect all Pro's philosophies, work and disciplinary procedures.
3. I will support the Club by:
  - a. Volunteering to help with any competitions hosted by or worked by Northern Blades NSC FSC.
  - b. Participating and/or volunteering in other Club activities as requested.
  - c. Paying my bills on time.
4. I will use the grievance procedure whenever I or my skater(s) has/have a problem which cannot be informally resolved.
5. I will read, understand and respect the policies of Professional Skaters Association regarding Solicitation, Promotion and Tampering. I agree not to participate in Solicitation or Tampering and to report instances as they occur.

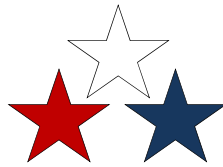


#### EXPECTATION OF ALUMNI

1. I will review the Expectations outlined above and will support and respect these Expectations.
2. I will be a role model and facilitate:
  - a. Individual growth and excellence in figure skating for all members of the Club.
  - b. Positive and constructive interaction between all members in the Club.
  - c. Respect and appreciation for the individual and unique personalities/skills of all members in the Club.
  - d. Feeling of “belonging” to the Club, Club unity and working together to accomplish Club goals.
  - e. Support and respect for all skaters participating in competitive events.
3. I will use the grievance procedure whenever I have a problem which cannot be informally resolved.

#### EXPECTATION OF PROFESSIONAL STAFF

1. I will be a role model and facilitate:
  - a. Individual growth and excellence in skating for all members of the Club.
  - b. Positive and constructive interaction between all skaters, parents, and Pros in the Club
  - c. Respect and appreciation for the individual and unique personalities/skills of all skaters and Pros in the Club.
  - d. Feeling of “belonging” to the Club, club unity, and working together to accomplish Club goals.
  - e. Support and respect for all skaters participating in competitive events.
2. I will support and respect other Pros and their philosophy, work and disciplinary procedures, and treat all skaters fairly.
3. I will cooperate with other Pros and skaters regarding space on the ice by moving around and using the whole rink, and holding meetings with groups of my skaters off the ice.
4. I have the authority to maintain a positive training atmosphere on the ice.
5. I will provide all of my students with written documentation of my fees and expectations upon contracting services with them.
6. I will talk to each of my students about proper skating procedures and behavior on the ice, following all of the Ice Rules as published by the National Sports Center and demand proper behavior at all times.
7. I will be responsible to be observant for inappropriate skating etiquette. If inappropriate skating etiquette is observed, the Pro of the skater involved and the Pro who observed the behavior will meet off the ice and all parties will address and resolve the problem. When possible, this should take place at the time of the incident. If the skater’s Pro is not present, the issue will be discussed with the skater, and the skater’s Pro will be notified as soon as possible.
8. If I need help with a problem, I will follow the appropriate Grievance Procedure, as outlined by the Board.
9. I will conduct myself chemically free (alcohol, illicit drugs) whenever coaching on an NSC ice session, exhibition or skating competition.
10. I will support the NBNSCFSC Board and the Club as I do my work and encourage my students and their parents or guardians to be active Club members and supporters.
11. I will actively participate in all Club sponsored clinics and seminars.
12. I will not request skaters to become home club skaters elsewhere and if I do this I will be subject to losing my membership status with the NBNSCFSC.
13. As a courtesy to my skaters, I will obtain permission from my skater and/or their parent before posting pictures or videos of them on social media.
14. I will abide by the Club’s mandatory two (person)-deep leadership for travel to and from practice sessions and competitions and **will not** participate in one-athlete and one-coach travel (unless I am the parent, guardian, or sibling of that particular athlete).



15. I will adhere to Club travel guidelines which must be signed and agreed upon by all members, parents/guardians, coaches and other adults traveling with the club.
16. Regardless of gender, I will not share a hotel room or other sleeping arrangement with an athlete (unless I am the parent, guardian, or sibling of such athlete).

### **U.S. FIGURE SKATING SAFESPORT**

Northern Blades National Sports Center Figure Skating Club (NBNSCFSC) is committed to creating a safe and positive environment for members' physical, emotional and social development and ensuring that it promotes an environment free of misconduct. Parents and skaters agree to familiarize themselves with the US Figure Skating SafeSport rules and regulations and agree to adhere to them.

### **NORTHERN BLADES NSC FIGURE SKATING CLUB APPLICANT STATEMENT**

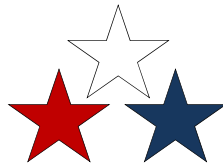

I hereby apply for membership in the Northern Blades National Sports Center Figure Skating Club ("Club"), a member club of the United States Figure Skating Association ("USFS") and agree that, in accordance with the By-laws of the Club, all membership applications are subject to approval by the Board of Directors in regard to class of membership, acceptance, or rejection. I will adhere to all Club & USFS rules in any and all activities. If I am applying for a skating membership I attest that I have neither tried out for nor appeared in any professional groups or shows, nor in any way violated amateur rules of the USFS. It is understood that the Club will take reasonable means to provide a safe experience for its membership. However, it is further understood that neither the Club nor its officers assume any financial responsibility for any accidents or incidents that may occur. Should it be necessary, I authorize Northern Blades National Sports Center Figure Skating Club to call for emergency medical treatment and will hold no member or Board of Director liable for treatment. I understand that to remain a member in good standing in the Club, I must pay all Club bills promptly. If any bills due to the Club are paid with checks that are returned for non-sufficient funds I agree that I will pay a handling fee of \$35 for the NSF check in addition to reimbursing any reasonable fees the Club may incur associated with the NSF check. This includes billings for membership, apparel, testing, exhibitions, and all other fees not specifically listed. I understand that if the requested payment becomes 30 days overdue without contacting the Club Treasurer, I will cease to be a member in good standing of the Club and will be disqualified from the following: USFS Testing, USFS Competitions, Contracting for Club Ice, participation in Club events such as exhibitions, social events, and individual fundraising opportunities.

### **WAIVER & RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT ("AGREEMENT")**

In consideration of participating in Northern Blades National Sports Center Figure Skating Club ("NBNSCFSC") activities, I represent that I understand the nature of figure skating activities ("activity") and that I am qualified, in good health and in proper physical condition to participate in such "activity". I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the "activity". I fully understand that this "activity" involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the "activity", the conditions in which the "activity" takes place, or the negligence of the "releases" named below; and that there may



be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the "activity". I hereby release, discharge, and covenant not to sue the Northern Blades National Sports Center Figure Skating Club, United States Figure Skating, its directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the "activity" takes place (each considered one of the "Releases" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the releases from any loss, liability, damage, or cost which any may incur as the result of such claim. The NBNSCFSC has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the NBNSCFSC shall not be responsible for the supervision of the members at Club Ice.

### **PARENTAL CONSENT & INDEMNIFICATION AGREEMENT**

I, the minor's parent and/or legal guardian, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such "activity". I hereby release, discharge, covenant not to sue and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS each of the Releases from all liability, claims, demands, losses, or damages on the minor's account caused or alleged to have been caused in whole or in part by the negligence of the Releases or otherwise, including negligent rescue operations, and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claims against any of the above Releases, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releases from any litigation expenses, attorney fees, loss liability, damage, or cost any Releases may incur as the result of any such claim.

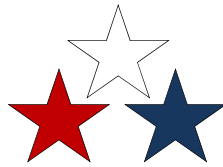

### **NORTHERN BLADES NSC FIGURE SKATING CLUB 2020-21 CLUB MEMBERSHIP SERVICE/VOLUNTEER POLICY & REQUIREMENTS**

---

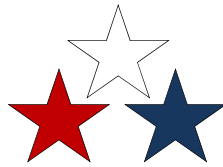
A Board of Directors runs the Northern Blades NSC FSC with many committees doing various duties; it is a non-profit, entirely volunteer club. The success of Northern Blades NSC FSC relies solely on the active and continuous support of its individual members and their families. The requirements for the 2020-21 skating season are as follows:

- Each Home Club family will be required to provide **10 hours** of service/volunteer time to the club during the membership year (July 1<sup>st</sup>, 2020 - June 30<sup>th</sup>, 2021).
- A \$250.00 volunteer deposit is required from each Club Family to be cashed only if the family fails to fulfill the minimum required hours by June 30<sup>th</sup>, 2021.
- A family can elect to "opt out" of the service/volunteer time requirement by writing a check to NBNSCFSC for \$200.00. This check will be cashed immediately.
- Each Home Club Family will be required to actively participate in **BOTH** the fall fundraiser and the Silent Auction in the spring.
- A \$200.00 fundraising deposit is required from each Club family to be cashed only if the family fails to fulfill the fundraising requirements.
- A family can elect to "opt out" of participating in the Club fundraisers by writing a check to NBNSCFSC for \$150.00. This check will be cashed immediately.
- Each member family will be responsible for entering their hours worked on the Track it Forward website at <http://www.trackitforward.com/site/northern-blades-nsc-figure-skating-club>. All hours should be submitted before June 30<sup>th</sup>, 2021.
- Hours not completed and/or submitted before June 30<sup>th</sup>, 2021 will not be counted.
- The volunteer deposit checks will be returned or destroyed upon full completion of the service/volunteer hours and fundraising requirements. If a family is short hours, up to 2, they can elect to pay for those hours instead of forfeiting the entire deposit check of \$250. Those missed hours will be charged at the rate of \$40 per hour missed. If a member decides to withdraw, change Clubs or in any way discontinue membership, ALL volunteer requirements must still be met, NO EXCEPTIONS.

### **VOLUNTEER OPPORTUNITIES**

There are numerous opportunities to complete the required service/volunteer hours to the club. Our Club's annual USFS competition "Rising Stars" which will take place October 25<sup>th</sup>, 2020, along

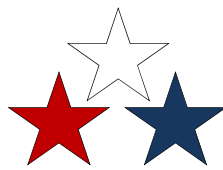




with the "Frosty Blades" ISI competition hosted by the National Sports Center (February 2021) should provide ample volunteer opportunities for members for the 2020-21 season, along with other various events and activities, such as the Annual Silent Auction (which takes place during the NSC Spring Ice Show), attending Board meetings, our Annual Banquet in May, monthly exhibitions, etc. In an attempt to distribute the volunteer time required for those major events (Rising Stars and Frosty Blades) equitably across families, we strongly encourage that everyone participate in these events even if you do not have a skater competing. Committees for various activities are also available for members to help with important tasks and earn volunteer hours!

#### **ADDITIONAL HOURS**

Members who work more than their required minimum requirements are awarded ice vouchers which are good for any **45 min contract ice session**. For every 5 service/volunteer hours worked beyond the required family minimum, families will receive 1 ice voucher. Vouchers earned during the 2020-21 season will have an expiration date of one year from the time earned. Families are capped at 200 additional volunteer hours after meeting their requirement. Any hours volunteered above and beyond the capped amount will not earn coupons (this is so that the Club does not have to issue 1099's to members and maintain our non-profit status).

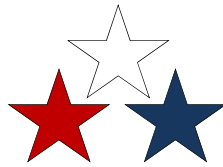

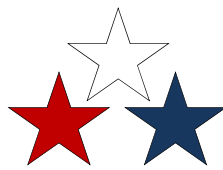
